### How do I know if my Fundraiser Application has been accepted?

After you have emailed, faxed or dropped off your application to the El Cholo of your choice, we will email you with details.

### How do I know if my organization is recognized by the government as a non-profit organization?

Please contact your organization, The Restaurant Business, Inc., El Cholo Restaurant, The Cannery and Café Maiz cannot provide you with this information. You may also search for your organization by its official name at [www.irs.gov](http://www.irs.gov)

### Do my guests need to dine in/at the restaurant to participate in my fundraiser?

If everyone can't stay for lunch/dinner, they can order take-out or pick up a catering platter. Your guest(s) must identify themselves with your organization for the date and time specified for the fundraiser. Their purchases will get credited to your fundraiser.

### How do I cancel or reschedule my fundraiser?

You may cancel your fundraiser within 48-hours notice of the scheduled event by contacting the General Manager at the restaurant.

### How much money did my organization make at our fundraiser?

Please contact the General Manager of the restaurant where you held your fabulous fundraiser to find out how much money your organization earned. This information is available three days after your event.

### When can I expect to receive my check?

Your fundraiser check will arrive 4-6 weeks after your event. If it has been more than six (6) weeks since your event and you still have not received a check, please contact our corporate office.
